Dear Voting Member of First Unitarian Church,

One of your rights and responsibilities as a voting member is to decide issues of significance to the church. To encourage the greatest possible participation in this annual election, the Board has again authorized a vote-by-mail process. This year you are asked to consider the recommended candidates to serve on the Board of Trustees and the Nominating Committee, as well as the church's operating budget for fiscal year 2023-2024.

The Nominating Committee is a committee of the congregation, separate from the Board. It is tasked with selecting qualified candidates to run each year for the Board, and for the Nominating Committee itself. The candidates on their proposed slates have been selected after a thorough vetting process that includes collaboration with the Board and Executive Team. The Board of Trustees recommends all of these candidates to you for election. The Board also recommends a "yes" vote for the fiscal 2023-2024 operating budget.

#### You will vote for:

#### For your ballots to be valid and counted, follow these instructions:

- Mark your choices in each category (Board of Trustees; Nominating Committee; Annual Operating Budget). Mark only the number of choices allowed. Voting for more than the allowed number of choices will invalidate your ballot.
- 2. Place the completed ballots in the small white secrecy envelope and seal it. To keep your choices confidential, DO NOT WRITE YOUR NAME ON THIS ENVELOPE.
- 3. Place the sealed secrecy envelope in the return envelope, which is printed with your name in the return address section, and seal it.

# Fiscal Year 2023-2024 – Budget Commentary

Budgets can offer a snapshot of where an organization is and where it wants to go. In the case of First Unitarian and the 2023-2024 fiscal year, the Church finds itself at a crossroads: the congregation is just a few months into a new senior minister's tenure; it is still in the process of coming out of the Covid phase where the congregation was largely virtual for over two years and where some individuals and families no longer feel as connected as they once did to the church. Fiscally the church is needing to move away from a number of years of overreliance on reserve funds that essentially allowed the church to live beyond its means. (\$128,500 from various reserves were used to balance the operating budget that was approved by the congregation last year, in May 2022.)

The 2023 annual fund drive came in about \$200,000 below goal. It should be noted that the previous year's campaign came in \$125,000 short of goal but a one-time gift meant that some of the more difficult budget decisions could be delayed. A Close the Gap campaign this spring brought in an additional \$50,000, which still left a significant gap in the congregation's funding going into this budget process. This budget attempts to place the church on more of a sustainable path going forward.

In consultation with the Board of Trustees, the Executive Team articulated priorities for the church as it continued to move out of the pandemic and as it entered a new chapter with a new senior minister. Those priorities included:

- Communications beyond our in-person & online "walls"
  - o social justice & community engagement
  - o communications & social media to prospective visitors
- Communications within
  - o building up friend/membership connections & engagement
- Welcoming & Befriending
  - Newcomers Experience
  - Hospitality with an 8th principle lens
- Pathways to Belonging & Commitment
  - membership development
  - o stewardship time, talent, treasure
- Lifelong Spiritual Growth & Learning
  - o large group and small group worship/spiritual practices (online, in-person, hybrid)
  - multigenerational and age peer group opportunities for learning, meaningmaking, moral development, and fun!

In addition the Executive team looked at comps from other UU congregations of our size for staffing. We discovered that in a number of areas our church had by far the largest staff and that in other areas of church life we were understaffed. It should also be noted that over the last several years the administration staff have seen more reductions, and generally increases have come to program staff.

Here are some important notes about this budget:

- --Income through pledges and contributions is expected to remain about the same as the church continues to rebuild
- --increased staff resources for communication, stewardship, and membership and volunteer engagement
- --reductions in program staff to better reflect guidelines and staff levels in other congregations of comparable size.
- -incorporating the compensation levels in the new union contract signed in June 2022 that brings that base wage for Union members up to \$20/hour.
- -works to bring the church into better alignment with the UUA compensation guidelines as they emerge. Where positions are at or near the midpoint of recommendations to keep that compensation relatively flat and where increases are needed to bring those positions up as the church is able.
- --plan to begin rebuilding the rental income stream that disappeared during the pandemic.

To fulfill our mission, a congregation's budget also needs to share resources throughout all the areas of congregational life in holistic ways. Here are the areas of congregational life, which have staffing costs and other expenses connected to them.




